We thank you for your request of 5<sup>th</sup> April. Accordingly, we have carried out a Mining Search on the above property and are able to report as follows:-

#### **Mining Activity**

The property is situated away from the principal metalliferous mining areas. It does not lie within a historically established former mining lease boundary and our plans and records do not indicate the presence of any mine workings, shafts or metalliferous mineral deposits under, within or adjacent to the boundaries of the property.

The nearest recorded mine workings are those of Brixham Iron Mines, which comprised a number of small opencast and underground mines situated at the southern end of Brixham, which were active during the mid-to-late nineteenth and early twentieth centuries. The exact locations and extent of these small mines are not fully recorded, but the largest was Sharkham Point Mine situated over 1.1 kilometres south-southeast of the property.

## Conclusions

Based on the documentary evidence available, we have no reason to believe that the property is likely to be adversely affected by past metalliferous mining activity. We are not aware of any plans to explore for, or exploit, metallic minerals in the locality and do not consider this a likely event.
